"Graduate in any stream with Diploma in Sports Coaching from NSNIS Patiala or its subsidiary Regional Institutes in the concerned discipline" should be read

"10+2 with Diploma in sports coaching in the concerned discipline".

AGE LIMIT

"Candidates should not be less than 18 years and not more than 30 years with 5(five) years relaxation for SC/ST/OBCs and 5(five) years further relaxation in case of SC/ST who are sports person with National Level achievements/Medallist. No age limit for those who are already in Meghalaya Government Service provided they entered service within the prescribed age limit" should be read as:

"A candidate should not be less than 18 years and not more that 40 years of age as on the last date of application, i.e. 23-12-2019. There is no age limit for those who are already in Government service provided they entered service within the age limit".
